## Radwaste – the democratic deficit

The NFLA Chair, NFLA Secretary and other NFLA members have attended Government workshops over its consultation on UK nuclear waste policy.

Two workshops – one for local government and one for NGO critics of UK policy - were held in London. Regional seminars were also held

around England and Wales (Scottish policy on waste is different).

A full NFLA response reflecting the comments made in its Policy Briefing is going to the Government prior to its December 5<sup>th</sup> deadline.

The NFLA response concentrates on the changes to the demo-

critic oversight of a deep underground repository project.

It also raises real concerns around little or no detail on long-term interim storage, the need for national geological screening and alternatives to a 'GDF'.

The NFLA Policy briefing is on its website.

## Hinkley C debate turns to European Commission

The NFLA Secretariat is working with its key partner cities in Europe as the next part of the challenge to UK new nuclear build goes to the EU's Commission.

In October, the UK Government and EDF announced an outline agreement of price guarantees for 2 new nuclear reactors at Hinkley Point.

Despite saying the deal involves no new public subsidies to EDF; it has to be approved by the EU as a legal form of state aid.

NFLA are consulting with the Vienna led 'Cities for a Nuclear Free Europe' to lobby several national governments and the Commission to challenge this request. NFLA have signed a joint Energy

Fair letter to the EU Commission opposed to the use of public subsidies for new build.

A legal challenge to the Hinkley decision by the Irish National Trust is being considered in early December.

EDF have confirmed its final decision to invest in the project will be made some time later in 2014.

**NFLA English Forum considers contaminated metal issues**

The NFLA English Forum held an informative seminar in Rotherham considering issues around contaminated metals.

Speakers included Steve Chandler from the Environment Agency, who outlined its project 'Reducing Risks from Radioactive Sources'.

Craig Ashton from the NDA's Low Level Waste Repository provided an overview of the NDA's policy for decontaminating metals.

Independent consultant Tim Deere-Jones outlined research he had undertaken for the NFLA raising concerns over the transporting

and recycling of such materials to Sweden.

There was a very useful and robust discussion on the issue and NFLA will conduct more research for a further policy briefing.

The presentations have been placed on the NFLA website.

**NFLA Secretary invited to speak at EU conference**

The NFLA Secretary has been invited to speak at a European Economic and Social Committee (EESC) Conference on crisis communications at civil nuclear sites in the EU.

The invitation to speak comes after the EESC were notified of the NFLA's reports and

seminars on nuclear emergency planning.

The NFLA Secretary has taken part in a detailed EESC inquiry. This is considering concerns of groups like the NFLA in how to deal with evacuating the public after a major nuclear incident similar to the Fukushima disaster.

The Conference will be held in February in Brussels. The NFLA Secretary is speaking in a session which will include a speaker from the Finnish nuclear regulator and EDF.

The EESC Conference provides a valuable opportunity for NFLA to influence policy.

## Manchester Mayors for Peace civic reception / NET response

The Lord Mayor of Manchester, who is a Vice President of Mayors for Peace, held a civic reception as part of his commitment to the 5,834 member towns and cities group.

The reception allowed for the conferment of Salahuddin Choudhry as a Mayors for Peace

2020 Vision Ambassador and the receiving of peace crane garlands from CND.

Mr Choudhry is a former Pakistan Consul-General to the UK and has many years of diplomatic experience at the UN.

The peace cranes were given to CND by the

'Gensuyiko' Hiroshima group following their 2013 Tokyo – Hiroshima peace walk. They will be given out to schools.

## Red Cross agrees on campaign to ban nuclear weapons

The NFLA welcomes a unanimous decision made in Australia by the International Red Cross to establish a four year campaign for the abolition of nuclear weapons.

This follows on from its 2012 resolution to call for nuclear weapons abolition and contains

concrete measures to follow up on this policy.

The four year action plans involves engaging in the raising of awareness and active dialogue with the public, scientists, health professionals and decision-makers.

The ICRC Action Plan

promotes support from national Red Cross groups, to co-operate on regional conferences and lobbying at the UN level.

NFLA and the Mayors for Peace will both benefit from this decision and will look to develop national and international links.
